Policy Update

• The League of Women Voters of New Jersey, along with partners including the American Civil Liberties Union of New Jersey, Fair Share Housing Center, Faith in New Jersey, Ironbound Community Corporation, Latino Action Network, Make the Road New Jersey, New Jersey Alliance for Immigrant Justice, New Jersey Citizen Action, New Jersey Institute for Social Justice, New Jersey Policy Perspective, Salvation and Social Justice, and Wind of the Spirit Immigrant Resource Center, among others, introduced their "People's Lame Duck Agenda" via virtual press conference on November 6th. Copies of the agenda were hand delivered to every legislative district office in an effort to push state legislators to address 20 stalled bills currently without a hearing. The agenda has a strong focus on racial and social justice, emphasizing issues such as voting rights reform, non-discriminatory home appraisals, and protections for immigrant communities. Policy Setbacks

 Offshore wind developer Ørsted has pulled the plug on wind farm projects off the New Jersey coast—a disappointment to proponents of clean energy alternatives such as the Jersey Renews Coalition, which is co-convened by Environment New Jersey and New Jersey Work Environment Council. Jersey Renews recently hosted its sixth annual Time for Turbines event to highlight New Jersey's progress toward alternative sources of energy. Though Ørsted's announcement is a setback to clean energy projects, several separate offshore wind projects are underway with other developers. Read more here and here.

Education Law Center (ELC) has long highlighted the state's failure to fully implement
the school funding formula, which has not been updated since 2008. Recalibration of
