Policy Updates

- The new state budget signed in June includes \$10 million to support increasing the number of electric vehicles on the road. The state Department of Environmental Protection is tasked with using the funds to install charging stations at businesses, multi-unit residential buildings, and public locations. - Make the Road New Jersey and partners celebrated a federal judge's decision to allow implementation of the Temporary Workers' Bill of Rights. As of August 5, staffing agencies are required to pay temp workers the same average rate and equal benefits as permanent employees, and may not make workers pay for meals and other expenses that would reduce compensation to below minimum wage. - In 2021, after advocacy from the New Jersey Alliance for Immigrant Justice (NJAII) and its allies, Governor Murphy signed a law prohibiting state, local, and private detention facilities from entering into federal agreements to detain noncitizens. Core Civic, currently running the state's last remaining private immigrant detention facility in Elizabeth, is suing Murphy and the Attorney General's Office over the law, which bars the company from renewing its

contract with U.S. Immigration and Customs Enforcement. Last month, the Biden Administration filed an amicus brief joining Core Civic to keep the detention facility open. NJAIJ and NJ Deputy Attorney General, David Chen, have publicly voiced their criticism of and opposition to Core Civic's practices. This case will be argued before a judge at the end of August.
