Grantee News

Policy Victories:

- As a result of advocacy by New Jersey Institute for Social Justice, American Civil Liberties Union New Jersey, and partners, Attorney General Grewal announced all New Jersey law enforcement agencies must publicly identify officers who commit serious disciplinary violations starting later in 2020 and every year thereafter. The new mandate comes as governments nationwide are grappling with public demand for more transparency regarding police abuse of power. Read more <u>here</u>.
- In an effort supported by the Housing and Community Development Network of New Jersey and partners, Governor Murphy announced the establishment of a \$100 million short-term emergency rental assistance program to aid individuals and families severely impacted by the pandemic crisis. Residents who are low-to-no-income, homeless, or at-risk of homelessness will be prioritized. Read more <u>here</u>.
- Following advocacy by the Housing and Community Development Network of New Jersey and partners, Governor Murphy announced new measures and resources for renters and

homeowners impacted by the pandemic, including allowing renters to use security deposits to cover rent, the launch of a FAQs page for tenants and landlords about rights and responsibilities, more information for homeowners, and an announcement about some larger landlords. Read more <u>here</u>.

- With support from New Jersey Institute for Social Justice, Salvation and Social Justice, and partners, a new law signed by Governor Murphy requires the reporting and release of racial and other demographic data regarding COVID-19 testing, attempted treatment, hospitalization, and deaths. This legislation is critical to understanding the impact of the coronavirus on vulnerable communities in the state. Read more <u>here</u>.
- As a result of advocacy by Pinelands Preservation Alliance, New Jersey Highlands Coalition, Association of New Jersey Environmental Commissions, New Jersey Conservation Foundation, Delaware Riverkeeper Network, and partners, the state Department of Environmental Protection suspended a key permit for the construction of the Southern Reliability Link (SRL) pipeline project after three recent drilling-related spills had caused the SRL pipeline to pollute sensitive environments. - Governor Murphy announced the development of the New Jersey Wind Port, the first port in the country specifically built for offshore wind manufacturing. The port is expected to create thousands of high-quality jobs, bring millions of investment dollars to the state, and establish New Jersey as the national capital of offshore wind, in keeping with priorities advanced by Jersey Renews. Policy Updates:

- Following litigation by the American Civil Liberties Union New Jersey and partners, the state's Superior Court ordered the Murphy administration to overhaul how it handles requests from prisoners to be released amid the pandemic, finding the state had not done enough to ensure prisoners' rights were protected. The slow rollout of Governor Murphy's executive order to safely release as many prisoners as possible to slow the spread of the coronavirus in state prisons led to New Jersey having the highest per-capita COVID-19 prison death rate in the nation. - Governor Murphy signed into law a bill that requires generators of food waste such as hospitals, prisons, restaurants, and supermarkets to recycle food garbage rather than send it to incinerators or landfills. Read more <u>here</u>.
- Based on research conducted by the New York Times in July, the Trump administration has
 officially reversed, revoked, or rolled back nearly 70 environmental rules and regulations and
 more than 30 additional rollbacks are still in progress; many have been carried out by the
 federal Environmental Protection Agency. These rollbacks could significantly increase
 greenhouse gas emissions and lead to thousands of extra deaths from poor air quality each year
 that could affect New Jerseyans. Read more <u>here</u>.
- Following litigation and advocacy by American Civil Liberties Union New Jersey and partners, New Jersey's Supreme Court heard arguments virtually in late April on a bid by the police union

in Newark to limit the powers of the Newark Civilian Complaint Review Board, powers which were previously restored by an appeals court. Read more <u>here</u>.

• Governor Murphy announced his support of an environmental justice bill that would require a cumulative impact analysis from the state Department of Environmental Protections when permitting in "overburdened" communities. This bill would protect particularly vulnerable communities from further environmental hazards caused by pollutants. Read more <u>here</u>.

Policy Reports:

- New Jersey Institute for Social Justice released a report highlighting the structural racism embedded in New Jersey's housing policy through nationwide government policies called "redlining" that excluded Black and other non-white families from owning a home in certain areas. The report proposes six recommendations to help close the racial wealth gap caused in part by these historic policies. Read more <u>here</u>.
- New Jersey Policy Perspective released a report reviewing New Jersey's many county primary ballot designs and comparing them to ballot designs from other jurisdictions across the country. New Jersey's confusing ballot designs often lead to voters incorrectly filling out the ballot and following the "party line" to the benefit of the majority county party organization. - New Jersey Policy Perspective released a report detailing how a decade of budget cuts to critical state departments came at a cost to public health and economic security, especially during a time of crisis when the demand for services is at an all-time high. Read more <u>here</u>.
- New Jersey Policy Perspective released a report proposing recommended revisions to the state's income tax code to raise revenue to strengthen the state's recovery from the pandemic crisis.

- Tri-State Transportation Campaign released a report aimed at public transit agencies, government officials, riders, and businesses to understand how to make mass transit safer in the COVID era. The report features over 50 recommendations to make transit safer for riders during and after the pandemic crisis. Read more <u>here</u>.
- Tri-State Transportation Campaign released a report surveying over 1,000 public transit riders across New Jersey, New York, Pennsylvania, and Connecticut about their thoughts on what they need to see from transit agencies in order to feel safe riding on trains and buses as the economy reopens. - New Jersey Work Environment Council, in partnership with the National Council for Occupational Safety and Health, released a report outlining comprehensive guidelines for workplace safety, worker participation, and fair compensation for sick, injured, and at-risk

workers. The report's purpose is to help protect and empower workers to build a more inclusive an equitable economy and to end health, social and economic disparities. Read more <u>here</u>.

- Jersey Renews released a report outlining 10 recommendations intended to guide the process for New Jersey's reopening and long-term just and green recovery that will simultaneously stimulate the economy. Read more <u>here</u>.
